Applying for a permit

When a completed animal permit application is lodged and the applicable fees have been paid, an inspection of your property by an authorised officer will be arranged with you. Upon the above being completed, you will be notified in writing if your permit is granted or refused.

Wodonga Council's *Local Law No. 4, Part L7.2* states:

- I. No person may without a permit keep or cause to be kept more than two dogs on any premises other than properties classified as Rural 1 for rating purposes, within the municipality.
- II. No person may without a permit keep or cause to be kept more than two cats on any premises other than properties classified as Rural 1 for rating purposes within the municipality.
- III. In determining whether to grant a permit, the authorised officer must have regard to any standards or guidelines set out in part 11 on this local law.
- IV. Sub-clause (one) does not apply where a planning permit has been obtained for land used for the purpose of animal boarding or breeding.

PART 11 (S8) KEEPING OF ANIMALS states:

In determining whether to grant a permit for the keeping of animals, the council must take into account:

- a) The zoning of the land;
- b) The proximity to adjoining properties;
- c) The amenity of the area;
- d) The type and additional numbers of animals to be kept;
- e) The likely effects on adjoining owners;
- f) The adequacy of animal shelters; and
- g) Any other matter relevant to the circumstance associated with the application.
